**MEMBERSHIP FEE INCREASE**

In order to continue the numerous benefits of membership, the Psi Chi Board of Directors has approved an increase to the lifetime membership fee. The last increase in membership fees was in 2000. The new membership fee will be \$45 beginning July 1, 2009. Membership registrations postmarked after July 1, 2009, that do not reflect the new membership fee (regardless of induction date listed), will be returned to the chapter for resubmission with the correct fees.
